Thank you for contacting Greenlight Safety Consultancy, this document aims to explain our process of assessing contractors in line with current legislation (CDM Guidance 8) and best practice.

How will this assessment process assist your organisation?

1. It will assist you in proving your competency when tendering for future works.
2. Other SSIP assessment schemes ([www.ssip.org.uk](http://www.ssip.org.uk)) will recognise and accept our certification should a client request a particular SSIP certification.
3. It will reduce the likelihood of accidents/incidents and near misses within your organisation.
4. The assessment process will help to improve your companies H&S management system.
5. It demonstrates that your organisation has had an external audit conducted.
6. It helps to fulfil your legal requirements under regulation 8 of the CDM Regulations 2015.
7. As stated within Guidance 8, Section 64 of the CDM Regulation 2015, an SSIP assessment can demonstrate organisational capability at the pre-qualification stage of the appointment process.

How do you become accredited:

1. Complete the attached questionnaire, checking your supporting documentation to ensure it is fully answering the question (e.g. ensure the document has been reviewed within the last twelve months).
2. Send your completed questionnaire with your supporting documentation to us for assessment.
3. Please send a cheque addressed to Greenlight Safety Consultancy Ltd £119.00+vat (£142.80). This payment covers our time and expertise to initially contact you, complete the assessment process (providing feedback were required), inputting your organisations information into our shared database, providing you with your certification and obtaining your new insurance certificate/schedule when your current insurances expire. We are unable to complete any assessments until we have received payment. ***The cost of next year's assessment will be £99.00 + vat. This saving is due to your understanding of the process which should reduce our time.***
